6. That a corpus fund of rupees 25 crores or as decided by the UGC from time to time, shall be created and maintained in the name of the Institution Deemed to be University.
7. That the interest accrued on the corpus fund shall be used only for the purpose of further development of the Institution deemed to be the University.
8. That the proposed Deemed to be University shall abide by all the provisions of the UGC Act, 1956 and the rules and regulations made under the said UGC Act including the UGC (Institutions Deemed to be Universities) Regulations, 2023.

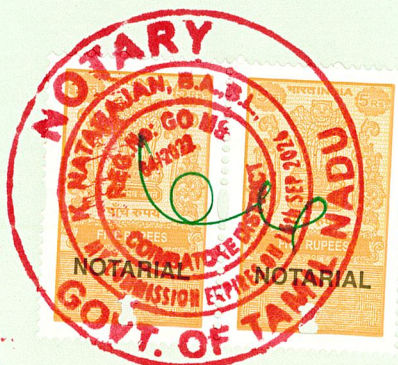
