Sl. No.	Points Discussed	Actions Taken
1.	Discussed about how the students are accessing the lecture materials and video lectures through a supportive learning environment called 'Wiki Site'.	The 'Wiki Site' has been developed to meet the academic needs of our students. This platform serves as a central hub for accessing essential academic resources. The faculty members will be uploading the lesson plans, lecture materials and video lectures on this platform. They make sure to provide these resources a day before each academic class. The students can login to the site using their institutional E-Mail ID and they can refer to the resources for their daily tests and examinations.
2.	Analyze the feedback received from II and III-year students on the various components.	The feedback was collected from a total of 845 and 888 students, respectively on the satisfaction level of skill training, special lab, reward point system, outcome-based questions, English module, mentoring and classroom/online teaching. The action taken is being documented by the IQAC-Student affairs vertical once in 3 months.
3.	Outcomes of industrial / institute training attended by the faculty members.	A total of 52 industrial institute training sessions were attended by the faculty members and they have provided training for other faculty members and students through Special Lab and Gurugulam.
4.	Report and Actions Taken of Non-academic audit Process	The audit for non-academic activities is conducted through 'Infrastructure Verticals', and the audit process includes year plan collection, preparation, and finalization of audit form, audit, report
