ORDER:-

In the letter read above, the Director of Industrial Safety and Health has stated that the Bannari Amman Institute of Technology, Sathyamangalam Erode District has submitted an application seeking approval of the Post Graduate course M.E. (Industrial Safety Engineering) for the appointment of Safety Officers in Factories as prescribed under Rule 3(1)(b) of the Tamil Nadu Safety Officers (Duties, Qualifications and Conditions of Service) Rules, 2005. He has further stated that they have obtained approval from AICTE, Anna University admission approval from DOTE, Chennai and the University having required faculty, infrastructure and laboratory facilities.
