Sir,

This has reference to NBA's letter of even number dated 01/12/2017 under which UG Electronics & Communication Engineering program offered by Bannari Amman Institute of Technology, Erode, Tamil Nadu was accredited in Tier I for the academic years 2017-18 to 2019-2020 upto 30/06/2020 with the observations that the Criteria for 30% Ph.D. in the department was not met. Therefore, the program had not qualified for accreditation for 6 years. If the Institution meets the pre-qualifiers before the expiry of the accreditation period awarded to the program, i.e. 30/06/2020, the Institute may submit pre-qualifiers again to NBA for consideration for full accreditation of 6 years, after completion of the Current Academic year(CAY) in which the pre-qualifiers are met.

2. The Pre- qualifiers submitted by Bannari Amman Institute of Technology, Erode, Tamil Nadu in respect of the UG-Electronics & Communication Engineering program have been considered. The program is meeting all the parameters of pre-qualifiers for full accreditation of 6 years. Accordingly, the competent authority in NBA has approved the following accreditation status to the program(s) as given in the Table below:

- 6. The accreditation status of the above program is subject to change on periodic review, if needed by the NBA. It is desired that the relevant information in respect of accredited program as indicated in the table in paragraph 2, appears on the website and information bulletin of the Institute.
- 7. The accreditation status awarded to the program as indicated in table in paragraph 2 above is subject to maintenance of the current standards during the period of accreditation. If there are any changes in the status (major changes of faculty strength, organizational structure etc.), the same are required to be communicated to the NBA, with an appropriate explanatory note.
